1. Agency Updates

Melbourne Water - Ross Bleazby

- Regenerative agricultural workshop was held at ECOSS.
- Q. In a previous meeting the removal of Wonga Vine was discussed. Is there a brief about the project?
- Q. Is there a brief or project outline on Silvan Reservoir tree removal?
- Q. Has Melbourne Water developed a strategy for logs/timber extraction from Silvan Reservoir?
- A. The logs/timber are left in situ unless they are deemed hazardous.
- Q. Water meter pumping system upgrade that prevents water theft and monitors water use could be used to warn users in advance when they are nearing usage limit.
- A. This has been discussed but at this time is not viable.

- Q. A bottle deposit scheme is needed.
- A. The Victorian State Government has announced one will begin on 1st November 2023. Bottles can be dropped in at reverse vending machines where a ticket is given redeemable at Woolworths and Coles.
- Q. Can compostable nappies be placed in the FOGO bin?
- A. Not at this time as the compost facility isn't able to sort them. It's difficult to tell the difference between compostable and non-compostable nappies. There is a company in Lilydale that recycles nappies for a cost. https://www.facebook.com/DiaperRecycle
- Q. Can people get a cost-reduction if they discard less waste? i.e. Don't put their bin out each week.
- A. Residents can opt to get the smaller 80L bin, however, waiving cost is not feasible as the main cost is in providing the service, the truck still needs to travel past that property, employees are still needed to drive the trucks etc.
- Q. What if you don't have a green waste bin because you compost? Do you have to pay for one?
- A. Providing a FOGO bin is compulsory as per State Gov requirements. The cost of the service is the same even if some people want to opt out, therefore, if Council made it optional the cost would be too high. There are two sized FOGO bins 120L and 240L. Costs can be minimised by choosing a smaller bin.
- Q. Do you have to use the Council-provided FOGO bags? Do you have to use a bag at all?
- A. No, you don't have to use a bag, however, if you do you must use the Council-provided one. To ensure minimum contamination, the staff at the processing plant will pull out any bags that aren't Council-provided ones.
- Q. What happens with the compost from the FOGO bins?
- A. Biogro buy the compost and onsell it through retailers such as Bunnings.
- Q. Do they screen for microplastics?
- A. They remove plastic items by hand and machine but some plastics will remain.
- Q. Can compostable coffee cups be put in the FOGO bin?
- A. Not at this time because many cups contain plastic and it can be difficult to tell which is which. Allowing coffee cups will contribute to contamination.
- Q. What happens with the bones in FOGO?
- A. The bones go through a shredding process, they are crushed and remain in the compost.
- Q. Could pathogens be a problem to the workers sorting if waste bins are only collected every 2 weeks?
- A. No, high temperatures in compost heap will kill the pathogens. It will be at 50 70 'c for at least 5 days.
- Q. How do we stop people from dumping their rubbish in FOGO because of the change from weekly waste collection to fortnightly?
- A. Bin audits will increase after the transition with notices placed on bins to help educate residents.
- Q. Have you thought about developing an app to assist residents with information about bin collection days and what to put out?
- A. We will look into it, for now we have a micro website that people can access, and our main website has an address lookup for bin collection dates/information.
- Q. With Redcycle soft plastics going out of business the key to getting soft plastic recycling up and running will be advocacy. What's going on with it?
- A. A new Melbourne-based company has begun working with some councils on this problem. It is on YRC's agenda to work with other councils to advocate to the State Government for soft plastics collections/recycling and the Federal Government for changes to production.
- Q. What is the life space of the bins?
- A. 15-20 years. All parts of the bin are recycled when they reach end of life.
- C. It would be good to hear from Bec Brannigan and community around this topic and the changes.
- C. (Graham Brew) We will be running community workshops and programs to help residents make the transition.

3. Open Floor

a) The food provided at the meetings isn't satisfactory, a proper dinner meal was provided in the past. A few lines have been cherry-picked from the catering policy in response to this issue; can we see the full policy.

Response:

- Yarra Ranges Council catering policy states catering can be requested for meetings that run for more than three hours. As this meeting is two hours we provide light refreshments, tea, coffee and water. The full catering policy can be provided.
