Before Applying

- The Domestic Animal Act 1994 states all cats and dogs over 3 months old must be microchipped and registered with council.
- Any pets currently living at the property are required to be registered prior to this application being processed - you can register online <https://www.yarraranges.vic.gov.au/Environment/Pets/Pet-registration/Register-your-pet>
- If your pets are currently registered - proceed with this application
- You will require a current email address
- You will need proof of concession card if applicable
- You will need to know the size of your land metres square. To check click on [Intramaps](#) and type your property address in the search tab.
