This form regards the latest response - below:</p> <p>CEO remuneration</p> <p>Tammi Rose was appointed as Chief Executive Officer on 18 December, 2018 with a total remuneration package of \$370,000.</p> <p>The CEO's salary is determined by Council annually in reference to the median of the category 1 Council criteria under the State Government Remuneration Survey.</p> <p>Yarra Ranges is one of the seven largest Councils in Victoria by population and turnover, hence the category 1 rating. We have over 900 employees and an annual budget of more than \$250 million.</p> <p>CEO salary packages are determined to attract high calibre candidates who are able to lead a large and complex organisation.</p> |

| Nature of support given | <p>Advised that complaints about the election are handled by the Local Government Inspectorate, who have a complaint form on their website that is specifically for election-related complaints and can be used to raise concerns in respect of any of the following:</p> <ul style="list-style-type: none"> • The content, authorisation or distribution of election material; • Whether a candidate is eligible to run for election; • A current Councillor is improperly using their position or Council resources for their election campaign; • Someone has tampered with, forged, stolen or interfered with ballot papers; • Someone tried to bribe, intimidate or otherwise improperly influence another person in order to get their vote or support; • Someone has misused the voters' roll; • Someone tried to bribe, intimidate or otherwise improperly influence another person in order to get them to run as a candidate; • Someone has done something they should not be doing at or near a voting centre, such as canvassing for votes. <p>Also advised that the information provided above will be published to Council's website under https://www.yarraranges.vic.gov.au/Council/Council-Elections-2020</p> |

| Nature of support given | <p>Advised that where a playspace is listed as retired this means it is being decommissioned and removed. This is usually because it has been assessed that there are many other options in the area nearby that have recently been renewed or are planned to be - i.e. an assessment of the spread in the overall network</p> <p>Advised that McDermott has not been sold, this is still Council-owned land. Plans for this space are yet to be confirmed.</p> <p>Valley Park Drive Reserve - this site was assessed in feasibility stage as not appropriate for development of a playspace, too steep, instead some seating furniture and paths were installed.</p> <p>Adding new playspace renewals to the plan - While the playspace plan is set up to be updated and reviewed, particularly for the medium term and long-term lists, we tend not to add to network as this has impacts on ongoing maintenance load. Should it be determined that a site listed as retire is to be retained and renewed, additional funding may need to be secured and this signed off by Council.</p> <p>Alternatively, could go through a process of finding a site to 'swap' in the same area - however this is yet to be done. When this has been considered in the past and both sites assessed, the original recommendations were not changed as a result. Often some sites have better conditions and exposure than others, or geographically are better suited to development. This is an analysis process officers can undertake if requested.</p> |

| Nature of support given | The Governance Coordinator raised the issue with Council's Client Liaison Officer at the VEC and the Election Manager for Yarra Ranges and received a reply on 30/09/20 that the VEC's Enrolment Branch will contact Mr Hill directly to address the concern. Mr Hill was advised by email of this and that as the VEC are the statutory body responsible for the organisation, management and delivery of the 2020 Council Elections, Council has no control over the format of the Electoral Roll, the provision of this to any candidate who requests it, or, the secure DEx platform operated by them. It was further advised that the matters raised should be addressed directly with the VEC. |
