

If you are concerned about a tree on a neighbour's property, speak to your neighbour first before taking action. If your neighbour would like to have their tree assessed by a Council arborist, please ask them to call us on 1300 368 333 to discuss the Private Tree Inspection process.

If your neighbour refuses to have the tree inspected through our Private Tree Inspection process, you can lodge the following request to inspect a tree on a neighbour's property with Council. We will have the tree inspected and will send the arborist report to you and/or your neighbour within two weeks.

Any action required relating to the tree potentially posing a risk to Council land will be enforced by Council, however any tree potentially posing a risk to private property will remain a civil matter to be managed between the property owners.

More information on your rights and responsibilities regarding trees on private property is available from the Dispute Settlement Centre of Victoria.

You have the right to prune an overhanging tree to the boundary fence line. You do not have the right to enter their property without permission.

To the fullest extent permitted by law, except for personal injury or death directly caused or to the extent contributed to by a negligent act or omission of Yarra Ranges Council, Yarra Ranges Council will not otherwise be liable to the Customer, whether in contract, tort (including negligence), under statute, in equity or on any other legal basis for any loss, damage (including economic and consequential loss or damage), injury, death, costs, charges or expenses resulting from or in any way connected with this service.
