Introduction

Purpose

Elizabeth Bridge Reserve is a valuable community recreational centre providing a wide range of formal and informal recreational uses.

This Master Plan aims to provide a comprehensive analysis and guidance for the future planning and programming of the Reserve to better accommodate it's existing users, as well as providing opportunities for additional activities and uses.

Context and History

Elizabeth Bridge Reserve is located in Kilsyth over an area of roughly 9.6 hectares. The site is separated into two distinct activity areas with the northern oval providing facilities for more formulated activities such as football and cricket, and the southern portion accommodating a wider range of low intensity/passive recreational opportunities.

The Department of Education and Training manage the former school site to the north of the Reserve and lease the oval area to Council.

The Friends of Elizabeth Bridge Reserve have been operating for over 13 years actively being involved in working bees on the first Sunday of every month (except January). These have seen the planting of a number of new species and keep the reserve looking well manicured. The wetland is currently managed by Melbourne Water.

Background Assessment

A extensive series of background studies and assessments were conducted as part of the master planning processes, including the review of the following:

Consultation

The local community and stakeholder groups were

engaged to seek insight into their wants. needs and general perception of Elizabeth Bridge Reserve and to identify the key features and characteristics considered valuable to them.

The initial consultation process for the Elizabeth Bridge Reserve Master Plan took place from September to November 2019 (194 responses), with further consultation undertaken in mid-2020 following public release of the draft Master Plan (74 responses).

Consultation review with key stakeholders, Council's Project Reference Group, representatives from Kilsyth Community Action Group and Friends of Elizabeth Bridge Reserve was undertaken in August 2020. This enabled a review of community feedback and to confirm that the draft Master Plan responded to the key issues and opportunities as identified during the early stages of the project. Consultation throughout the project covered a number of formats as listed below:

- Council internal workshops;
- Local user group and stakeholder engagement sessions;
- Briefings with the Kilsyth Community Action Group & Friends of Elizabeth Bridge Reserve;
- (2) Community drop-in session on site in 2019;
- Direct mailing and online surveys.

A summary of the results can be found in the Elizabeth Bridge Reserve Background Report.

Formalise entry and upgrade the boundary treatment at Beatrice Street to improve the entry experience

Additional meandering gravel path through the forest area to provide additional nature and sensory play opportunities and 'Bush Kinder'.

Upgrading the pedestrian circulation with an additional formal sealed/accessible path connection from the Bridge House to the forest area. An additional sealed path will also be installed connecting the car park area with western activity area.

4

Upgrades to the existing picnic/gathering amenities with additional shelter areas with BBQ, and picnic tables around the existing play space. The location of these amenities will also be within close proximity to the drinking fountain, bin and toilet block.

5

Refurbish the existing play space in the short term, and progressively improve the play space with additional equipments over the next 10 years. The play space will be upgraded to district level by 2032.



Provide fitness stations and improved path lighting around the reserve to promote active recreation and to improve user safety



Wetland:

Upgrade the existing concrete lookout into a boardwalk, allowing better interaction with the wetland and promoting the use of natural materials. The board-walk will include barriers and signage to improve safety, particularly with younger children.

Incorporate interpretation/information for wetland.

Review existing bridge access treatments to allow for safe access for all.

Installation of a new activity precinct just north of the car park area. This precinct will focus on active recreational activities and will include a multi-use half court and a shelter space for outdoor fitness. A new toilet block will also be located along the path intersection to better accommodate level of usage at the Reserve. This space will also be used for community events and gatherings when required.

New pedestrian entry and expanded car park along the Durham Road frontage. The formalised pedestrian entry will serve to indicate pedestrian priority and remove conflict with vehicles. Improvements will improve accessibility. New entry signage will be installed to include the history of the Reserve. The new car park area (1 way travel) provides additional parking amenity for the users, as well as minimising conflict with vehicles by providing a circulation loop.

Upgrades to the Bridge House with fresh paint to the building exteriors and the installation of a new sensory garden.

Additional public art opportunities around the wetland area to provide additional character and amenity for the Reserve. The art works will also function as a visual connection to unify the different activity areas.

Removal of the existing under utilised amphitheatre to expand the lawn area. A smaller seating/viewing area will be retained adjacent to the existing path to retain the passive recreation opportunities. A larger new large shelter area will be located at the top of the ridge to provide activation and act as a lookout both into the wetland and the dog off-leash areas to the east and west.



Explore opportunities for additional parking along Durham Road to accommodate larger community and sporting events.

Provide a dog off-leash area in the existing lawn area at the eastern end of the Reserve extending down the hill to the amphitheatre area to the west.



Upgrades to the oval and surrounds includuing a barrier net behind the southern goal, new drainage, turf, fences, gravel paths, lighting and cricket practice nets.

New toilet/change facilities to the northern boundary of the oval with emergency and disabled vehicle access.

Advocate for car park and road access in the future site works to activate the Reserve and associated activity spaces.

Master Plan Implementation

The total cost to implement the proposed EBR Master Plan over the 10 + years is estimated to be \$5 million. A summary of the recommendations, approximate cost and time frames for each precinct are listed as follow.

The State Government have allocated \$700,000 to the short term initiatives through a recent grant.

General park improvements

Additional to the breakdown of improvement into each of the activity precincts, the Master Plan also recommends an overall improvement to the facilities and amenities within the Reserve, such as the footpaths, general seating, lighting, signage and wayfinding, etc.






